# LAE Information & Contacts for COVID-19 Inquiries (as of March 25, 2020)

Government's best advice is to follow the science and follow the facts. Below are some resources that may help answer some of the employment-related questions you may have.

### **Workplace Safety**

- We appreciate that some individuals are concerned about their exposure to COVID-19. If COVID-19 is
  identified as a potential workplace hazard, workplace parties have the duty to develop internal process
  to reduce risk to their staff. Should an employee feel there is a hazard that puts them at risk they should
  review the situation with their immediate supervisor / manager. If not resolved, then the matter is to be
  referred to the Joint Occupational Health and Safety Committee if one exists.

#### Labour Standards - Pay and Job Security

- The NS Labour Standards Code provides job protection for employees who are unable to perform work
  due to an emergency as defined under the Code. Emergency includes a direction or order of a medical
  officer or a public health emergency declared under the Health Protection Act. Emergency leave
  extends to individuals who need to care for a family member affected by an order or direction under
  that Act.

#### **Financial Supports to Workers and Businesses**

- On March 18<sup>th</sup>, the Government of Canada announced a \$82 billion aid package to help Canadian workers, students and businesses deal with some of the current financial challenges caused by the global COVID-19 pandemic.
- For individuals: in addition to Employment Insurance (EI) benefits, new supports for those not EI-eligible include an Emergency Care Benefit and Emergency Support Benefit; a top-up payment in May for those receiving the Canada Child Care Benefit and GST credit; a six-month interest-free suspension on the repayment of Canada Student Loans; enhancement of the EI work-sharing program; and an extension of tax filing and payment deadlines. - For businesses: a three-month wage subsidy for small businesses; a Business Credit Availability Program to support businesses experiencing cash flow challenges; deferred tax payment deadlines; and more to

 The Province has further announced a six-month interest-free suspension on the repayment of Nova Scotia Student Loans. Plus, suspension of payments and increased access to credit under the Small Business Loan Guarantee Program and deferral of payments on all government loans and small business renewal fees (including business registration and workers compensation) until June 30<sup>th</sup>. ## **Post Secondary Education**

- Most post-secondary institutions have suspended face-to-face classes in favour of remote education and are in communication with their students regarding the completion of the term.
- Individual private career colleges are moving to remote delivery or suspending programs, depending on their capacity and the program type. Programs with mandatory work practicum components have been disrupted by workplace closures. Colleges are waiting on COVID- 19 developments to best assess options for resuming program delivery for students. For additional information from government, please phone 902-424-5636.
